NALCO SMILES AWARDS

This award may be conferred annually. The total number of award in a year shall be 1 (one).

The Award may be conferred for distinctive contribution and achievements of NGO's or Institutions for rehabilitation & re-settlement of differently-abled children or persons.

The result of their activity or programmes must have directly resulted in the welfare & upliftment of the local population or the differently-abled children or persons, as the case may be.

Eligibility

- Individuals or organizations working in the NGO space or
- Individuals or organizations in the area of rehabilitation and re-settlement of differently-abled children or persons.
- Must have filed income tax returns for 3 previous years.

Rules & Regulations

- a) Individuals must reside in Odisha.
- b) The work must be in the State of Odisha.
- c) A NGO/Institution who has received the Smile Award earlier will not be eligible for the award in subsequent years.
- d) NALCO reserves the right to give the award even if there is only one application or withhold the award.
- e) NALCO accepts no liability for any loss resulting from the disclosure of information concerning an entry to assessors or jury members, though all reasonable precautions will be taken to maintain secrecy.
- f) NALCO cannot undertake to return documents or supplementary submitted with an entry.
- g) NALCO reserves the right to alter the award scheme, at any time.
- h) The assessors or jury may be nominated to confirm or clarify certain facts at site.
- i) Travel and stay expenses, if any, will be met by the applicant. In the case of awardees the expenses may be met by the awardees unless the company agrees to do so.
- j) Decision of the Award jury is final and no appeal or correspondence will be entertained.

The presentation of the award will be made in Bhubaneswar on 7th of January on the occasion of NALCO Foundation Day.
