### NALCO holds 39th Annual General Meeting on the Virtual Platform

Speaking on the occasion of the 39<sup>th</sup> AGM, Shri Sridhar Patra, CMD, NALCO, said that, “Year 2019-20 has been a year of mixed results for the company. In spite of an extremely challenging business environment, coupled with slump in prices and onset of COVID 19 pandemic in the last quarter of the year, we have made exemplary contribution in promoting and putting focus on *plant, production, productivity and people*”. He further added that, “Sustainability has now become a part of NALCO’s key business processes. The year was a testimony to NALCO being a partner in progress in promoting inclusive growth as an industry leader and spreading happiness amongst people”.
