We have examined the registers, records and books and papers of **M/s National Aluminium Company Limited** (the Company) as required to be maintained under the Companies Act, 2013 (the Act) and the rules made thereunder for the financial year ended on 31st March, 2021. In our opinion and to the best of our information and according to the examinations carried out by us and explanations furnished to us by the Company, its officers and agents, we certify that:

A. The Annual Return states the facts as at the close of the aforesaid financial year correctly and adequately.

B. During the aforesaid financial year the Company has complied with provisions of the Act & Rules made there under in respect of:

1. Its status under the Act;
2. Maintenance of registers/records & making entries therein within the time prescribed therefor;
3. Filing of forms and returns as stated in the Annual Return, with the Registrar of Companies and Stock Exchanges are within the prescribed time or in the extended time with or without fees or additional fees and the Company is not required to file any other forms or returns with Regional Director, Central Government, the Tribunal, Court or other authorities;
4. Calling/ convening/ holding meetings of Board of Directors, Audit Committee, CSR & Sustainability Development Committee, Stakeholders Relationship Committee and the meetings of the Members of the Company on due dates as stated in the Annual Return in respect of which proper notices were given and the proceedings including the circular resolutions have been properly recorded in the Minute Book/Registers maintained for the purpose and the same have been duly signed.

During the year under review, in absence of Independent Directors on the Board w.e.f 08.09.2020, the Company has not reconstituted the Statutory Committees, i.e. Audit Committee, Nomination and Remuneration Committee, CSR & Sustainability Development Committee and Stakeholders Relationship Committee, as the composition of these Committees need minimum number of Independent Directors.

During the year under review, the Audit Committee did not meet minimum four times and the chairman of the committee did not have accounting or related financial expertise as required under the provisions of the Act and SEBI (LODR) Regulations.

As per provisions under SEBI (LODR) Regulations, the Nomination and Remuneration committee should meet at least once in every year. However, the committee has not met during the year under review.

As per provisions under SEBI (LODR) Regulations, the quorum for every Board meeting shall be one-third of the total strength or three Directors whichever is higher including at least one Independent Director. In absence of Independent Directors on the Board w.e.f 08.09.2020, the meetings of the Board held on 11.11.2020, 18.11.2020, 27.01.2021, 12.02.2021, 15.03.2021 and 23.03.2021 were without valid quorum.

5. The Company had fixed Wednesday, 2nd December 2020 & Tuesday, 23rd March 2021 as the 'Record Dates' for payment of 1st interim dividend & 2nd interim dividend for the financial year 2020-21.

Also the Register of Members and Share Transfer Books of the Company remained closed from 28th September, 2020 to 30th September, 2020 (both days inclusive), for the purpose of the 39th Annual General Meeting of the Company.

6. During the financial year, the Company has not advanced any loan, or given guarantee or provided security in connection with any loan taken by its directors and/or persons or firms or companies referred in Section 185 of the Act.
7. During the financial year, the Company has not entered into any related party transactions and all the transactions made were during the ordinary course of business and on arm's length basis. Therefore the provisions of Section 188 of the Companies Act, 2013 are not attracted.
8. During the financial year, the transfer and transmission of shares in physical mode and issue of share certificates wherever required were done in conformity with the Act. There was no issue, allotment, alteration or conversion of shares during the period. The Company does not have any preference shares or debentures, so redemption of the same is not applicable.

During the financial year, in total 2,89,85,711 shares were bought back and extinguished on 17.03.2021. Post buyback, the paid-up share capital of the Company stood at ₹918.32 crores from ₹932.81 crores. The shareholding of Govt. of India post buyback reduced from 51.50% to 51.28% of total paid-up share capital. The buyback process was completed in compliance with the provisions of the Companies Act, 2013 and SEBI Buyback Regulations, 2018.

Total 1,83,47,99,995 equity shares constituting 99.90% of the total equity of NALCO (1,83,66,31,787 shares) are held in dematerialized form as on 31.03.2021.

9. The Company has appointed M/s. KFin Technologies Private Limited, Hyderabad as its Registrar and Share Transfer Agents (RTA) for share registry operation of the Company of the Company for a period of 3 years w.e.f. 01.04.2020.

10. During the financial year, the Company has kept the rights to the dividend in abeyance, pending registration of transfer of shares in compliance with the provisions of the Act. The Company has not issued any right shares and bonus shares during the period under review.
11. During the financial year under review, an amount of Rs.10,38,882/- pertaining to unclaimed interim dividend for financial year 2012-13 and an amount of Rs.6,85,923/- pertaining to unclaimed final dividend for financial year 2012-13 have been transferred to Investor Education and Protection Fund on 26.05.2020 and 05.11.2020 respectively.

During the financial year under review, the Company has transferred 29,173 shares of 100 shareholders in respect of which dividend has not been paid/claimed for seven consecutive years, to the IEPF Authority.

12. During the financial year, the audited financial statement was signed as per the provisions of section 134 of the Act and report of directors was made as per sub-sections (3), (4) and (5) thereof.
13. During the financial year, appointment, re-appointments, retirement, disclosures of the Directors, Key Managerial Personnel and remuneration paid to them are in compliance with the provisions of the Act.

However, during the financial year composition of the Board of Directors was not in compliance with the provisions of the Act and SEBI (LODR) Regulations.

Non-compliance under Companies Act, 2013:

As per proviso to Section 149(1)(b) of the Companies Act, 2013, every listed company shall have at least one Woman Director on the Board. Further as per Section 149(4) of the Companies Act, 2013, 1/3rd of the total strength of the Board should be Independent Directors.

During the year under review, the Company did not have requisite no. of Independent Directors at any point of time, Further, there is no Independent Director on the Board w.e.f 08.09.2020 including at least one woman director and the position remained vacant till 31.03.2021.

Accordingly, the composition of the Board is not in compliance with the provisions under Section 149(1) and 149(4) of the Companies Act, 2013.

Non-compliance under SEBI (LODR) Regulation, 2015 (The Regulations)

As per the Regulation 17(1) (a) of the Regulations, not less than 50% of the Board of Directors shall comprise of Non-Executive Directors. Provided, there should be at least one Independent Woman Director.

Further, as per Regulation 17(1) (b) of the Regulations, if the listed company does not have a regular Non-Executive Chairperson, at least half of the Board of Directors shall comprise of Independent Directors.

As on 31.03.2021, Non-executive Directors i.e. Part-time Official Directors constitute 33.33% of the total Board strength. The Company did not have requisite no. of Independent Directors at any point of time during the year under review. Further, there are no Independent Directors on the Board w.e.f 08.09.2020 including minimum one woman director and the position remained vacant till 31.03.2021.

Accordingly, the composition of the Board is not in compliance with the provisions under Regulation 17(1)(a) and Regulation 17(1)(b) of the SEBI (LODR) Regulations, 2015.

14. During the financial year, appointment of auditors has taken place as per the provisions of Section 139(5) of the Act.
15. During the financial year, no approvals was required to be taken from the Central Government, Tribunal, Regional Director, Registrar, Court or such other authorities under the various provisions of the Act.
16. During the financial year, the Company has not accepted, renewed, repaid any deposits.
17. During the financial year, the Company has not borrowed any amount from its directors, members, public financial institutions, banks and others and has not created, modified, satisfied any charges.
18. During the financial year, the Company has made investment in equity in existing Joint Venture Companies.
19. During the financial year the Company has not altered any of the provisions of the Memorandum or Articles of Association of the Company.
