(A) Clause No. 2.1 (i.e., Technical Eligibility Criteria) of Annexure-II of above mentioned NIT to be read as follows instead of existing:

2.1 <u>Technical Eligibility Criteria</u>

- 2.1.1 The bidder should have experience of having successfully completed "Similar Work" during the last Fifteen (15) years ending on last day of the month previous to the one in which NITs are invited, should be either of the followings;
- (i) Three "similar works" each costing not less than Rs. 42.04 Crore.

OR

(ii) Two "similar works" each costing not less than Rs. 52.55 Crore.

OR

(iii) One "similar work" costing not less than Rs. 84.08 Crore.

Evaluation criteria:

Cost of completed works by the bidder shall be escalated @ 10% per annum (simple rate) to bring them at the current price level.

(The cost of work completed within one year prior to original date of bid opening shall not be considered for any weightage. The weightage shall only be considered for work completed prior to one year of original date of bid opening on annual basis and no weightage shall be given for part of the year.)

"Similar Work" means:

"Design/ engineering, supply, erection and commissioning of one bulk material handling system including all associated structural steel/ civil works with conveyor having capacity minimum 900 TPH (rated) for Coal/ other materials having bulk density equivalent or more than Coal, in India, which should have been in successful operation for at least one (1) year since commissioning".

OR

"Design/ engineering, supply, erection and commissioning of at least one Wagon Tippler system along with side arm charger and associated conveyors as one integrated system in any Coal Handling Plant, in India, which should have been in successful operation for at least one (1) year since commissioning".

2.1.2 **Documentary proof required**:

- (i) The bidder to submit copy of the following documents duly attested by a notary public or Gazetted office.
- (a) Order value, Scope of Work & Bill of quantity for assessment of Experience Criteria
- (b) Satisfactory Completion Certificate indicating the value of work executed & period of contract obtained from Principal Owner of the work for whom the work has been executed.
- (ii) In case the bidder submits the credentials as a sub-contractor, the following copies are to be submitted duly attested by a notary public or gazette officer:
- (a) Detailed work order/PO/Agreement from the main agency.
- (b) Completion certificate issued by main agency indicating the value of work executed & period of contract.
- (c) Completion certificate issued by the Principal / project authorities in favour of the main agency showing due completion of the package.
- (iii) Performance certificate issued by the Principal/ project authorities in favour of the main agency showing the installed system is in successful operation for at least one year since commissioning.
- (iv) Bidder other than manufacturer of Wagon Tippler, shall supply the same from OEM/OES however, a certificate/ agreement from OEM/OES for back to back guarantee/warrantee support for the supplies, spares & after sales support shall be submitted.

Note: The experience/ completion certificates shall be considered only when it bears the Name and Designation of issuing authority. This is only applicable for experience/ completion certificates issued after 30.06.2022.

(B) Clause No. 2.2 (i.e., Financial Eligibility Criteria) of Annexure-II of above mentioned NIT to be read as follows instead of existing:
