The bidder has to quote the unit rates in the blue coloured cells upto t wo decimals only in the EXCEL sheet BOQ. Unit rate shall be excluding GST. After filing up the BOQ, the value obtained in the TOTAL AMOUNT INCLUDING GST Shall be quoted as the price for the contract in GeM po rtal. The bidder has convert this EXCEL sheet to PDF and upload the sa me in GeM portal at the Financial breakup location.

The bidder must submit duly fill up, signed and sealed annexures of NI T and EMD along with BID document.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
