OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. This is a PROPRIETARY, Single part tender hence, registered vendors from NALCO's i.e. "M/s. Bruker India Scientific Pvt Ltd." shall be considered only. Unsolicited bidders shall not be considered and subject to rejection during first cover bid opening.
2. The Technical bid first part will be for elimination of unsolicited bidder and to verify submission of EMD by the solicited bidders. The price will be opened for the solicited bidder only.
3. The party has to submit requisite EMD amounting of Rs. 20,000/- along with bid document.
4. The bidder should fill-up sign and seal Annexure of NIT and submit the same along with the bid documents for consideration and further acceptance.
5. The applicable GST rate for this contract is 18%. The items rates/amount must be quoted by the bidder in format as available in the GeM Portal including GST @ 18%.
6. The party has to convert this EXCEL sheet to PDF and upload the same in GeM portal at the Financial break up location.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
