However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. This is a PROPRIETARY, Single part tender hence, registered vendors from NALCO's i.e. " M/s. Bruk er India Scientific Pvt Ltd." shall be considered only. Unsolicited bidders shall not be considered and subject to rejection during first cover bid opening.
- 2. The Technical bid first part will be for elimination of unsolicited bidder and to verify submission of E MD by the solicited bidders. The price will be opened for the solicited bidder only.
- 3. The party has to submit requisite EMD amounting of Rs. 20,000/- along with bid document.
- 4. The bidder should fill-up sign and seal Annexure of NIT and submit the same along with the bid doc uments for consideration and further acceptance.
- 5. The applicable GST rate for this contract is 18%. The items rates/amount must be quoted by the bi dder in format as available in the GeM Portal including GST @ 18%.
