1. This is a PROPRIETARY, Single part tender hence, registered vendors from NALCO's i.e. "M/s. Thermo fisher Scientific India Pvt. Ltd" shall be considered only. Unsolicited bidders shall not be considered and subject to rejection during first cover bid opening.
2. The Technical bid first part will be for elimination of unsolicited bidder and to verify submission of EMD by the solicited bidders. The price will be opened for the solicited bidder only.
3. The party has to submit requisite EMD amounting of Rs. 20,000/- along with bid document.
4. The bidder should fill-up sign and seal Annexure of NIT and submit the same along with the bid documents for consideration and further acceptance.
5. The applicable GST rate for this contract is 18%. The items rates/amount must be quoted by the bidder in format as available in the GeM Portal including GST @ 18%.
6. The party has convert this EXCEL sheet to PDF and upload the same in GeM portal at the Financial break up location.
