#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- This is a PROPRIETARY, Single part tender hence, registered vendors from NALCO's i.e. "M/s. Smar t Techno System (India) Pvt. Ltd" shall be considered only. Unsolicited bidders shall not be considered and subject to rejection during first cover bid opening.
- 2. The Technical bid first part will be for elimination of unsolicited bidder and to verify submission of E MD by the solicited bidders. The price will be opened for the solicited bidder only.
- 3. The party has to submit requisite EMD amounting of Rs. 20,000/- along with bid document.
- 4. The bidder should fill-up sign and seal Annexure of NIT and submit the same along with the bid doc uments for consideration and further acceptance.
- 5. The applicable GST rate for this contract is 18%. The items rates/amount must be quoted by the bi dder in format as available in the GeM Portal including GST @ 18%.
- 6. The party has convert this EXCEL sheet to PDF and upload the same in GeM portal at the Financial break up location.
