1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other

than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## 2. **Generic**

## 5. **Scope of Supply**

## 6. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

## 7. **Buyer Added Bid Specific ATC**

- a. Please submit all signed documents as per our NIT/specification. In case of non-submission of any of the documents asked in the bid document, the offer may be liable for rejection without any clarifications.
- b. No payment term other than in GEM GTC (unless it is specifically mentioned in the GEM Bid) shall be acceptable. Any deviation may be liable for rejection of your offer.
- c. Please accept unconditionally all the conditions of GEM GTC unless otherwise it is specifically mentioned in GEM bid.
- d. As mentioned in GEM GTC, the quoted price in the offer must be inclusive of all taxes, freight etc. Bidders are requested to ensure the same before quoting. No extra cost can be added in quoted price after opening of offers. In case anything is quoted extra, bid evaluation shall be done without considering the extra charge and contract shall be placed, if emerged as L-1, with quoted price in GEM bid only.
- e. **Inspection and Testing:-** The Inspection and Testing shall be carried out as per TECHNICAL SPECIFICATIONS OF NIT.

The materials to be supplied shall have a Guarantee of 12 months from the date of use against defective design, faulty materials of construction, poor workmanship and unsatisfactory performance. The Guarantee Certificate to this effect shall be sent by you along with the supply.
- g. **Test certificate:-** Manufacturer's Material Test Certificate from reputed/ Govt./NABL approved laboratory against the supply portion shall be submitted along with the supply.
- h. **Performance Guarantee Certificate:-** The Performance Guarantee Certificate against Supply, Erection, repairing & Commissioning in order to achieve the Guaranteed Performance parameters as stipulated in the Technical Specifications of the NIT.
- i. **For relaxation of "prior turnover & prior experience" criteria to all start-ups recognised by Department of Industrial Policy & Promotion (DIPP), Ministry of Commerce & Industry, Govt of India, following clause shall be part of NIT, which is mentioned below.**
