In continuation to our letter dated 14.03.2024 under reference and in terms of Regulation 30 read with Schedule-III of SEBI (LODR) Regulations, 2015, this is to inform that, Ministry of Mines, Govt. of India vide Order no. A08/7/2023-Vig.-Part(1) dated 30.07.2024 has communicated that, the President, in exercise of the powers conferred by Rule 23(5) of NALCO Conduct, Discipline and Appeal Rules, has revoked the suspension of Shri Radhashyam Mahapatro with immediate effect, pending finalization of the investigation.

Further, Ministry of Mines, Govt. of India Order no. 3/1/2023-Metal-I dated 30.07.2024 has informed that, the Competent Authority has decided to attach Shri Radhashyam Mahapatro at NALCO Office, New Delhi, until further order, to handle the co-ordination work with Ministry of Defence on the Utkarsha Aluminium Dhatu Nigam Limited (a Joint Venture of NALCO and MIDHANI) to fast track the project.
