OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- This is a LTE, Single part tender hence, registered vendors from NALCO's approved vendor list shall be considered. Unsolicited bidders shall not be considered and subject to rejection during first cover bid opening.
- The LTE first part will be for elimination of unsolicited bidder and to verify submission of EMD by the solicited bidders. The price will be opened for the solicited bidders only.
- The party has to submit requisite EMD amounting of ` 1,25,000/- along with bid document.
- The bidder should fill-up sign and seal Annexure of NIT and submit the same along with the bid documents for consideration and further acceptance.
- The applicable GST rate for this contract is 18%. Bidder has to quote, including GST & Profit in Rupees up to two decimal points over and above Minimum Workable Value (including 18% GST) of ` 1,59,16,043.88.
- Offers with same or less than Minimum Workable Value of ` 1,59,16,043.88 including 18% GST shall be rejected.
- The party has to convert this EXCEL sheet to PDF and upload the same in GeM portal at the Financial break up location.
