1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

### 3. Buyer Added Bid Specific ATC

1. Description of Item : Low Voltage - Control Cables

2. Bidder's Scope:

The scope of bidder includes Design, Manufacture, Inspection, Testing, Packing & Forwarding, transportation complete as per MR. The bidder is also responsible for submission of final technical documentation / drawings as per vendor data requirement.

3. Prices on the GeM portal are inclusive of all cost components and taxes. Accordingly, bidders must quote prices in the GeM portal on a FOT Nalco Damanjodi site basis (including charges of inspection and testing, packing and forwarding charges, freight charges and applicable GST).

4. Price Schedule Format is attached under "Excel upload required" of this GEM BID. The price quoted in GEM portal shall be same as the final unit price arrived under excel Column-H (inclusive GST) of this attached Price Schedule Format. In case of any mismatch in the value under excel column H with the rate quoted in the GEM portal, GeM portal value shall prevail and will be considered for price evaluation.

5. Payment term: The payment will be released as per following payment terms:

100% payment along with taxes & duties shall be payable as per following break up:

a. 85% payment on pro-rata basis for order value against dispatch documents through bank along with 10% GST on order value.

b. 5% payment against receipt of final technical documentation / drawings as per vendor data requirement specified in the technical specifications.

c. last 10% payment within 30 days of receipt and acceptance of materials at site.

The vendor will have to raise invoice for the applicable GST amount as per approved format for claiming the GST paid.

NALCO, being Buyer (under Section 194Q inserted in the Income Tax Act, 1961 vide Finance Act 2021) having total sales, gross receipts, or turnover from business above Rupees Ten Crores during the last Financial Year, will deduct TDS under Section 194Q, w.e.f. 01.07.2021, at the prescribed rate of 0.1% on the purchase value of any goods, aggregate of which is exceeding the threshold limit of Rs.50 Lakh in a Financial year.

Accordingly, Vendors/Sellers are advised not to take any action to collect tax at source under section 206C (1H) of the Act w.e.f. 01.07.2021, in case provisions of section are applicable to vendors.

The above is as per the current status and is subject to modification(s) based on amendments/ notifications under Income Tax Act, 1961.

Vendors / Contractors categorized/ designated as "specified person" under Section 206AB of Income Tax Act, 1961 shall be liable for TDS at higher rate as provided under the said section, by NALCO. #### 6. Contract-cum-Performance Bank Guarantee (CPBG) :

The Vendor shall furnish a Contract Performance Bank Guarantee, for 5% of the total order value (excluding GST) as per NALCO's format, executed by any of the banks listed in the Appendix enclosed with the ITB. The Vendor shall submit the CPBG within 21 days of placement of BOA. This CPBG shall be valid for a period of three months beyond expiry of the contractual guarantee period of 12 months from the date of successful commissioning of the Plant or 30 months from the date of last dispatch, whichever is earlier.
