5. ALL THE NECESSARY FORMS MUST BE DULY FILLED UP AND SUBMITTED, ALONG WITH SIGN AND SEAL.

6. GST @ 18% OR AS APPLICABLE.

7. GST CESS @ 0%.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
