2.	This is a LTE, Single part tender hence, registered vendors from NALCO's approved vend or list shall be considered. Unsolicited bidders shall not be considered and subject to rejection during first cover bid opening.
3.	The LTE first part will be for elimination of unsolicited bidder and to verify submission of EMD by the solicited bidders. The price will be opened for the solicited bidders only.
4.	The party has to submit requisite EMD amount of Rs. 1,75,000/- along with bid document.
