2.1	<b><u>As per approval of CA the tender is to be floated on STANDARDIZED, SINGLE PART, e-tender through GeM Portal basis.</u></b>
2.2	This is a Standardized, Single part tender hence, registered vendors from NALCO's approved vendor shall be considered. Unsolicited bidder shall not be considered and subject to rejection during first cover bid opening.
2.3	The Proprietary first part will be for elimination of unsolicited bidder and to verify submission of EMD by the solicited bidders. The price will be opened for the solicited bidders only.
2.4	The party has to submit requisite EMD amount of Rs. 4,000/- along with bid document.
2.5	The bidder should fill-up sign and seal Annexure of NIT and submit the same along with the bid documents for consideration and further acceptance.
2.6	The applicable GST rate for this contract is 18%. The items rates/amount must be quoted by the bidder in format as available in the GeM Portal including GST @ 18%.
2.7	The party has convert this EXCEL sheet to PDF and upload the same in GeM portal at the Financial break up location.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
