2.2	This is a Proprietary, Single part tender hence, registered vendors from NALCO's approved vendor (i.e. M/s. Getinge Medical India Pvt. Ltd shall be considered. Unsolicited bidders shall not be considered and subject to rejection during first cover bid opening.
2.3	The Proprietary, Single first part will be for elimination of unsolicited bidder and to verify submission of EMD by the solicited bidders. The price will be opened for the solicited bidders only.
2.4	The job will be awarded to 01 (One) agency.
2.5	The party has to submit requisite EMD amount of Rs. 4,000/- along with bid document before tender opening date.
2.6	The party has to submit original Litigation History (Annexure-C22) as per NIT along with bid document before tender opening date.
2.7	The bidder should fill-up sign and seal Annexure of NIT and submit the same along with the bid documents for consideration and further acceptance.
2.8	The applicable GST rate for this contract is 18%. The items rates/amount must be quoted by the bidder in format as available in the GeM Portal including GST @ 18%.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
