### Invitation for Expression of Interest (EOI) from organisations involved in the business of Utilisation of Red Mud.

**Subject: EOI (Expression of Interest) for lifting of Red Mud from Red Mud Pond-1 (RMP-1), NALCO, Damanjodi.**

#### **A) Background:**

National Aluminium Company Limited (NALCO), a Navratna CPSE under the Ministry of Mines, Government of India, is one of the largest integrated primary aluminium producers in the country. NALCO operates a state-of-the-art 2.275 MTPA Alumina Refinery at Damanjodi, Koraput district, Odisha.

There exists one red mud pond at Alumina Plant Damanjodi to store the waste red mud generated from the refining process.

The alumina refining process at Damanjodi generates approximately 3 million tonnes of bauxite residue (Red Mud) annually, in addition to existing legacy stocks. In alignment with our commitment to zero-waste valorisation and global environmental best practices, NALCO invites **Expressions of Interest (EOI)** from organisation engaged in utilisation of red mud.

<b>Connectivity:</b>	Road: The Red Mud Pond-1 (RMP-1) is at a distance of around 15 Kms from NH-26. The site is connected to NH-26 by a bitumen/bituminous road.  Railway: The nearest railway station is 5 Km from the site.

**C) Scope of Work:**

- Collection/lifting of red mud shall be done from the Red Mud Pond-1 (RMP-1) of Alumina Refinery NALCO, Damanjodi.
- Conversion into useful products shall be done at their (i.e. agency/bidder) end.
- **Quantity of red mud to be collected/lifted/disposed-off by the bidder/agency: 10.00 lakhs MT**
- **Cost:** To be excavated/lifted/disposed-off by the agency/bidder on chargeable basis to NALCO. The actual charges/prices shall be decided during finalisation of the contract. The Red Mud is to be excavated/lifted/disposed-off by the agency/bidder on as is where is basis. The transportation is to be arranged by the bidders themselves.

- The agency must be a registered organisation.
- The agency must have permission from SPCB/ CPCB/MoEF&CC for utilisation of red mud.
- The bidders may visit the site before submission of bids.
- The statutory clearances required for handling/transportation & disposal at the agency's designated location/place shall be in the scope of the agency/bidder.
