For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 50 percent with the consent of the service provider

2.2	This is a Proprietary, Single part tender hence, registered vendors from NALCO's approved vendor shall be considered. Unsolicited bidder shall not be considered and subject to rejection during first cover bid opening.
2.3	The Proprietary first part will be for elimination of unsolicited bidder and to verify submission of EMD by the solicited bidders. The price will be opened for the solicited bidders only.

2.5	The job will be awarded to 01 (One) agency.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority.
